

Welcome to the Peconic Estuary!

The Peconic Estuary is an estuary of national significance and a vital coastal ecosystem essential to the environmental and economic well-being of the people in the surrounding communities.

Just 80 miles east of the hustle and bustle of New York City lies the unparalleled beauty and tranquility of Long Island's Peconic Estuary. A vital coastal ecosystem, the Peconic Estuary is abundant with animal and plant life. These natural resources are essential to the economic well-being and quality of life of the residents of eastern Long Island, as well as its visitors arriving by sea and land.

The Peconic Estuary watershed begins at the headwaters of the Peconic River, spans the several bays from Flanders to Gardiners, and ends in Block Island Sound between Plum Island and Montauk Point. Because of the Estuary's ecological health and socio-economic significance, it is one of twenty-eight estuaries in the nation to receive the designation of "Estuary of National Significance" by the U.S. Environmental Protection Agency.

While still resource rich, the water quality and habitat in the Peconic Estuary are degrading due to a variety of human activities and pollutants including boat waste, floatable debris, septic system discharges, agricultural and residential fertilization and illegal dumping. Please help protect, restore and enhance the Peconic Estuary to ensure a healthy and diverse marine ecosystem into the future. In this way together we can sustain the Estuary's recreational and commercial productivity for years to come and future generations.



TRANSIENT ANCHORAGE

Shelter Island Town Code §§ 128-5 and 128-6 allows overnight, transient anchoring not to exceed 48 hours in any 72-hour period in only 2 harbors: Coecles Harbor and West Neck Harbor, as shown below.

(May 15th to September 15th)

Safe Operation in Ferry Zones

Regulations prohibiting dangerous wakes and other reckless operation will be strictly enforced in the channels plied by the South and North Ferries.

Reckless operation is a misdemeanor, and the enforcement officer may terminate your voyage. Always observe the Rules of the Road and be courteous to other boaters.

(June 2022, SIPD)

Personal Watercraft (PWC)

- Prohibited from all creeks, beaches, and harbors except during transit to and from designated areas
- Cannot be operated after sunset or before sunrise
- Cannot be operated within 500 feet of any bathing area or shoreline
- Observe all speed regulations and restrictions, not to exceed 20 mph

Shellfishing

Licenses available to Shelter Island Town residents only

Private Moorings

Unauthorized use of private moorings is prohibited and a violation of Town Code

Speed Limits

- Boating speed limit is 5 mph within 100 feet of shore, a dock, pier, raft, float, an anchored or moored vessel and in the following Shelter Island creeks: West Neck Creek, Menantic Creek, Congdon's Creek, Gardiner's Creek, and Chase Creek.
- No boats shall exceed 45 mph in any Shelter Island waters.

Waterskiing, Tubing

Waterskiing, tubing, and similar watersport activities must stay 300 feet away from any shoreline and must stay 150 feet away from any public or semipublic bathing beach or public dock.

Mashomack Preserve

Shore access and landings are prohibited along the shoreline of Mashomack Preserve

Trash Disposal

- Trash and recyclables can be disposed at the Town's Recycling Center
- Town disposal bags are available in 3 sizes and can be purchased at various local merchants, Town Hall, and the Recycling Center

Dog Ordinance

- Dogs are not allowed on Wades, Shell and Crescent Beaches, between Memorial Day and Labor Day

Boats Stored on Town Landings

All vessels, canoes, kayaks, paddleboards, sailboats, dinghies, etc., stored on Town property must have a valid "Boat Storage on Town Property" sticker. For Town residents only. Apply for this permit at the Shelter Island Police Dept. Headquarters during business hours. **Boats stored on Town property not displaying a valid sticker may be removed by the Town without prior notice.**

Crescent Beach Special Notice to Boaters Anchoring off Crescent Beach

Anchoring off Crescent Beach requires skill and vigilance. The water deepens quickly; the tide runs strong and produces a counter current; and the wind swirls down from the high cliff areas. Be aware that the current and/or wind may shift during your stay and your boat may swing in another direction. Leave sufficient room between you and your neighbor's vessel. If you go ashore, check your boat from time to time to be sure your anchor is holding.

If you violate any of the restrictions below you may be issued a summons.

Crescent Beach - Anchoring and Operating Restrictions

No anchoring or motorized vessel operation is allowed within the perimeter of the regulatory markers (white buoy marked with an orange diamond and a cross within the diamond). These buoys are approximately 400' off shore. A summons will be issued if you anchor or transit this area at any speed. To drop off and pick up passengers you must stay out of this area, preferably to the east of the chain link fence on the eastern end of this area, by the bathrooms on the beach.

Cable Crossing. No anchoring over the cable crossing. Use the yellow **CABLE CROSSING** sign on the beach as a guide to keep away from this area. The cable runs on the seabed from Shelter Island to Conklin Point, Greenport, and is the only source of electricity for Shelter Island.

5 mph speed restriction within 100-feet of any anchored boat. You will see all manner of water activities in this area, swimmers, kayakers, stand up paddleboards, PWC, etc. When transiting this area, you must be cautious, which includes being vigilant and staying within the 5 mph speed limit. This restriction is strictly enforced.

NO PWC operation within 500-feet of the swim area unless going most direct route (90°) to or from the beach not to exceed 10 mph. If you are operating a PWC from your yacht, remember that each person operating must be over 14 and have a Safe Boating Certificate.

Stand up paddle boarders (SUPs) must have a PFD (personal flotation device, lifejacket) on the board, one for each person. For safety's sake, it is preferable that you wear your PFD. PFDs are required to be worn by children under 12 years of age. A whistle or other sound signaling device is also required to be carried.

On any vessel, underway, at any time, children under 12 years of age must wear a properly fitting PFD anytime they are out of the cabin.
